



The best deal for parking in Lincoln

Do you work for a business in the Lincoln Business Improvement District?

Lincoln Business Improvement Group has negotiated a bulk purchase deal for Business Improvement Group Levy Payers and their employees to park more cost effectively in the city centre. **This scheme allows you to park in designated car parks, seven days a week for 24 hours a day.**

You can purchase a pass which is valid in designated car parks listed under the option of your choice, **choose either:**

Option 1

A car pass valid for the following City of Lincoln Council car parks:

- ↗ Langworth Gate
- ↖ The Lawn
- Broadgate (multi-storey)
- ← King Street & Chaplin Street

Option 2

A car pass valid for the following NCP car parks:

- ↙ St Mary's Street
- St Rumbold's Street
- ↖ Hungate

Purchase either a company flexi-pass that can be used by any member of staff or customers on any vehicle.

Or, individuals can purchase a pass for their own vehicles (2 registration numbers can be given to allow for car sharing).

What does it cost? Only £53.17 per month (plus £25.00 one-off start up fee)

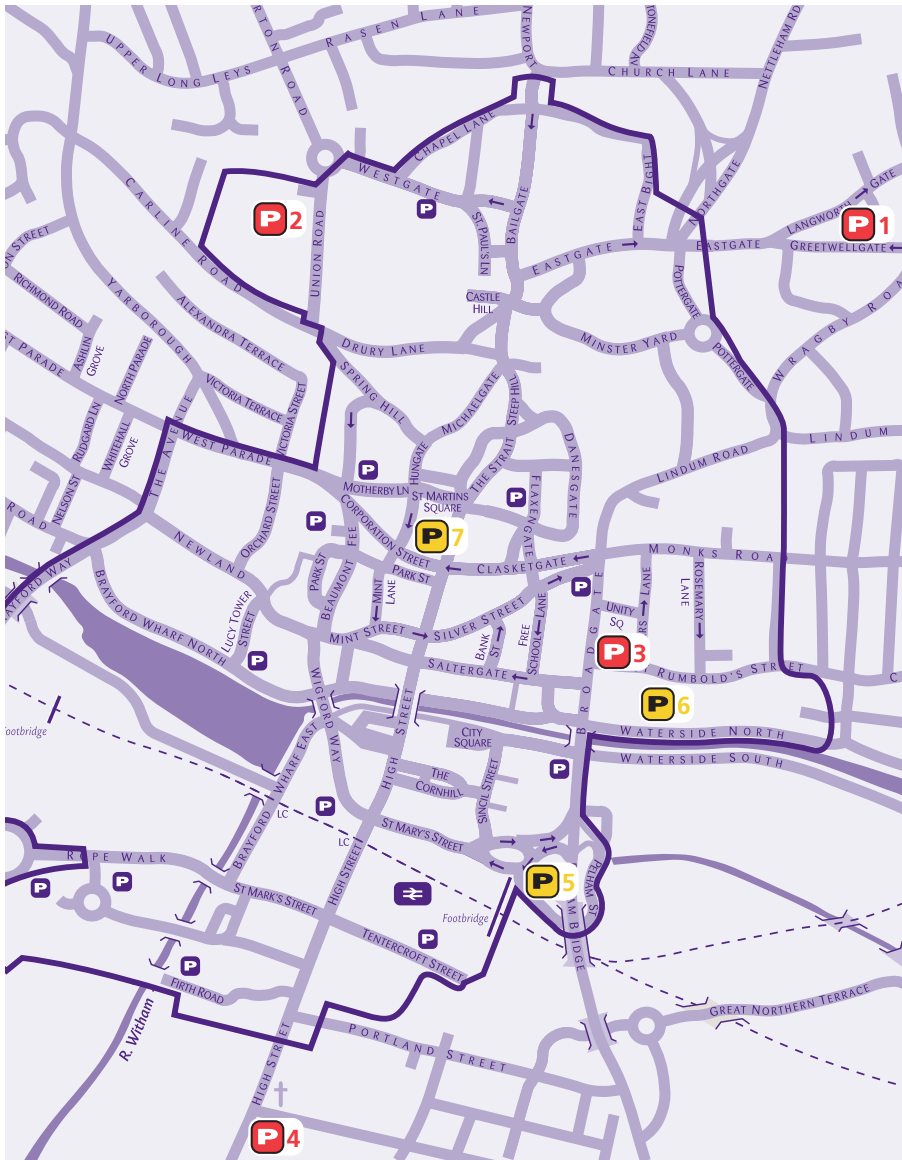

Will I be guaranteed a space?

We have targeted car parks that are less pressurised for this deal and where there are normally spaces available all week, however some car parks may get busy at peak times or during events.

Your pass is valid only in any of the car parks of your option choice and can be used in an alternative car park listed under that option if your first choice is full. Passes from Option 1 are not valid in Option 2 car parks and vice-versa – you may risk a fine if you use your pass in the wrong car park.
